AutoMeasure Calculation Parameters

Measures pertaining to both ambulatory and inpatient settings

- Up-to-date problem list
 - o Numerator: patients with at least one problem list entry or an indication that no problems are known for the patient recorded as structured data
 - o Denominator: all unique patients seen during the reporting period
 - o Threshold: >80%
- Active medication list
 - Numerator: patients with at least one medication entry or an indication that the patient is not currently prescribed any medication recorded as structured data
 - o Denominator: all unique patients seen during the reporting period
 - o Threshold: >80%
- Active medication allergy list
 - Numerator: patients with at least one medication allergy entry or an indication that the patient has no known medication allergies recorded as structured data
 - o Denominator: all unique patients seen during the reporting period
 - o Threshold: >80%
- Record demographics
 - o Numerator: patients with all required demographic elements recorded as structured data
 - o Denominator: all unique patients seen during the reporting period
 - o Threshold: >50%
- Patient-specific education
 - o Numerator: patients provided patient-specific education resources
 - o Denominator: all unique patients seen during the reporting period
 - o Threshold: >10%
- CPOE
 - o Numerator: patients with a medication order entered using CPOE
 - Denominator: all unique patients with at least one medication in their medication list
 - o Threshold: >30%
- Vitals, BMI, Growth charts
 - o Numerator: patients 2 and over with height, weight and blood pressure recorded as structured data.
 - o Denominator: all unique patients age 2 and over seen during the reporting period
 - o Threshold: >50%
- Record smoking status
 - o Numerator: unique patients 13 years or older with smoking status recorded as structured data
 - Denominator: all unique patients 13 years or older seen during the reporting period
 - o Threshold: >50%

- Incorporate lab test results
 - o Numerator: clinical lab tests with positive/negative or numeric format results incorporated into EHR as structured data
 - o Denominator: all clinical lab tests ordered during the reporting period
 - o Threshold: >40%
- Electronic copy of patient health information
 - o Numerator: patients who request an electronic copy of their health information receive within 3 business days
 - o Denominator: all patients who request an electronic copy of their health information
 - o Threshold: >50%
- Medication reconciliation
 - o Numerator: Number of transitions of care in the denominator where medication reconciliation was performed
 - o Denominator: Number of transitions of care during the EHR reporting period for which the EP was the receiving party of the transition
 - NOTE: Transition of Care is defined as the movement of a patient from one setting of care (hospital, ambulatory primary care practice, ambulatory specialty care practice, long-term care, home health, rehabilitation facility) to another
 - o Threshold: >50%
- Patient Summary Record
 - o Numerator: Number of transitions of care and referrals in the denominator where a summary of care record was provided.
 - Denominator: Number of transitions of care and referrals during the EHR reporting period for which the EP was the transferring or referring provider.
 - NOTE: Transition of Care is defined as the movement of a patient from one setting of care (hospital, ambulatory primary care practice, ambulatory specialty care practice, long-term care, home health, rehabilitation facility) to another
 - o Threshold: >50%

Measures pertaining only to ambulatory setting

- Timely Access
 - Numerator: electronic access of health information provided to seen patients within 4 business days of being made available to EP and updated into their EHR
 - o Denominator: all unique patients seen during the reporting period
 - o Threshold: >10%
- Generate and transmit eRx
 - o Numerator: permissible prescriptions transmitted electronically
 - o Denominator: all permissible prescriptions
 - o Threshold: >40%
- Clinical Summaries

- Numerator: clinical summaries of office visits provided to patients within 3 business days
- o Denominator: all office visits
- o Threshold: >50%

• Patient reminders

- o Numerator: appropriate reminders sent to patients 65 years or older or 5 years old or younger during the reporting period
- o Denominator: all unique patients 65 years or older or 5 years old or younger
- o Threshold: >20%
